Chi Omega Fraternity At University of California, San Diego Constitution

ARTICLE I: NAME

The organization shall be called Chi Omega at University of California, San Diego in reference to the Kappa Lambda Chapter of the Chi Omega Fraternity at the University of California, San Diego.



ARTICLE II: OBJECTS

The objects of this non-profit student organization are to promote friendship, high standards of personnel, sincere learning and credible scholarship, participation in campus activities, community service, and career development.

ARTICLE III: MEMBERSHIP

New members should be undergraduate women matriculated at University of California, San Diego. They are to be selected in accordance with the recruitment procedures of the Fraternity and the University and who are actively working to fulfill the new member requirements. A new member has one calendar year in which to fulfill the requirements.

- A. New members must attain a 2.0 G.P.A. scholastic average based on a 4.0 system, on a minimum of 12 college credit hours, the quarter preceding Initiation, taken at this university.
- B. New members must meet all financial obligations prior to Initiation.
- C. New members must participate in 1 quality campus activity during their New Member period.

Section 2: Actives

Active members are undergraduate women matriculated at the university who have completed the requirements of the new member period and have been initiated. They must be actively working to achieve their degree.

Actives must participate in 5 hours of community service per quarter.

Actives must participate in 2 quality campus activities.

ARTICLE IV: DUES AND FEES

Section 1: Dues and Fees broken down:

Quarterly dues (3 times per year)

New Member Fee (one time, due 10 days after becoming a New Member)

Initiation Fee (one time, paid prior to initiation)

Building Fee (one time, paid prior to initiation)

Badge Fee (one time, paid by end of first year)

Liability Insurance (annually to Fraternity)

Parlor Fee (House Corp. Fee)

Membership Fee (annually, once initiated)

ARTICLE V: MEETINGS

Section 1: Chapter Meetings

Formal meetings will be held each Monday evening during the school year in the designated room on campus.

ARTICLE VI: OFFICERS

Section 1: Officers

The officers of the chapter shall consist of the President, Vice President, Secretary, Treasurer, New Member Educator, Personnel Chair, the Panhellenic Delegate, Director of Programming, Recruitment Chairs, and the Social Chair.

Section 2: Officer Elections

The election of officers shall be conducted in accordance with the Officer Selection Procedure dictated by the Chi Omega National Headquarters. In order to be slated for an office, the member must be in good standing and have a minimum cumulative G.P.A. of 2.65. If an elected officer's cumulative G.P.A. falls below a 2.65, she must resign her office. Slating shall occur in Fall Quarter. Rotation of officers shall occur in the last half of fall quarter.

Section 4: Officer Vacancies

Vacancies among elected officers shall be filled according to the Officer Selection Procedure dictated by the Chi Omega National Headquarters.

ARTICLE VII. RISK MANAGEMENT
